Email

A fund transfer directed to an email address associated with a proxy, rather than a direct bank account number. This is used in BI-FAST payment where an email address acts as a proxy or identifier for the recipient's account. The email address is linked to the recipient's bank account, and the funds are transferred accordingly.

Mobile Number

When a mobile number is used as a proxy for BI-FAST transactions, it functions similarly to using an email address as a proxy. The mobile number serves as a unique identifier linked to the recipient's bank account.

Account Number

When using a normal account number for financial transactions, you're directly addressing the specific bank account where the funds should be transferred.



- 4. Enter the Beneficiary Bank for BIFAST Details with Account Number in the Payee bank ID field.
- 5. Click Verify Payee to confirm that the account number and bank details provided match those of the intended recipient. If the information is valid, the beneficiary's name will be retrieved. This step ensures that the beneficiary's details are accurate before proceeding with the transaction.
